- **Reading of 6/11/24 meeting minutes**: The minutes were read by Jeanice; Motion to accept the minutes as read made by Doris, 2nd by Elaine, motion passed.
- **Financial Report**: Presented by Scott as of 8/31/24: <u>Total Operating Funds</u>: \$10,872.25; <u>Total Reserve Funds</u>: \$133,401.14; <u>Total Delinquencies</u>: \$9,441.52.
- **Board Appointment**: Lisa Browder was appointed by the board to fill the open board position after Kim's resignation.
- Officer Positions: <u>President</u>: Jeanice Horn; <u>Vice President</u>: Elaine Elliston; <u>Secretary</u>: Doris Elliston; <u>Treasurer</u>: Scott Horn; <u>Director</u>: Lisa Browder.
- **Landscaping Project:** This project involves installing plants next to the block fence on Castle Rock Road. Jeanice presented a quote from Martinez Garden Services in the amount of \$2,318.00. Elaine made a motion to accept their proposal, 2nd by Doris, motion passed.

Two Amendments To Homeowners' Association (H.O.A.) Documents:

- 1) Correction of the H.O.A.'s name: <u>From</u>: Sutton Place Home-Owners' Association, Inc.; <u>To</u>: Sutton Place Of Tampa Homeowners Association, Inc.
- 2) Allow the H.O.A. to collect all monies owed to the H.O.A. when home ownership has changed.
- **Exterior Maintenance**: Replacement of rotted wood at 1715 and 1719 Castle Rock Road is in the process of being completed.
- Gutter Cleaning Quotes: Chris received an initial quote in the amount of \$3,000. Motion made by Scott to have Chris present the board with 3 quotes, not to exceed \$3,300; 2nd by Doris, motion passed.

Speed Bumps: Motion made by Elaine to table the installation of speed bumps; 2nd by Doris, motion passed.

Roof Replacement Project: Chris is in the process of obtaining quotes, 2 have been obtained, but more will be obtained to be discussed at the next board meeting. The project should start sometime in 2025.

Crowder Landscaping Quote:

- Part 1) Removal of leaves from fence line and dumpster: \$600;
- Part 2) Cut back Bougainvillea plant and hauling and disposal of bags of garbage and debris: \$575.

 Total quote amount: \$1,175.

Visitor Parking Spots: It was suggested by Elaine that the 2 visitor/guest parking spots on each end of the plant bed island be eliminated due to constant abuse and new signs placed that read "No Parking, Will Tow".
